Charitable Tax Deductions

The CARES Act and the Consolidated Appropriations Act (CAA) include tax incentives for donating in 2021. Charitable giving can play a key role in your tax planning while you support organizations whose missions are important to you.

One important limit to keep in mind is that, traditionally, you can deduct charitable contributions only if you itemize deductions. However, the CARES Act generally allows up to \$300 of cash contributions to public charities to be deducted "above the line." This means the deduction reduces your adjusted gross income (AGI) and you don't have to itemize deductions to claim it. The CAA extended this break through 2021 and also, increases the maximum deduction to \$600 for married couples filing jointly.

The Bryan Area Foundation and its affiliates are qualifying charitable entities for your donation. If you'd like to take advantage of the CARES Act charitable tax deduction, we'd like to invite and encourage you to make a donation to the fund of your choice, or our General Community Funds which are used to fund and serve the most timely and urgent needs of Williams County.

Bryan Girls Softball Association Receives \$110,000 Grant!



Bryan Girls Softball Association (BGSA) received a grant of \$110,000 from the Bryan Area Foundation to help fund improvements to Field 5 in Bryan's Recreation Park. Recently, the existing press box was taken down and concrete was poured behind home plate, extending from the visitor dugout to the home team dugout, allowing for increased seating capacity, ADA accessibility and better visibility.

A new press box will be added on top of the home dugout/ concession stand, complete with a new sound system and scoreboard. Field 5 is utilized for kids ages 6-18 in the BGSA summer softball programs and is the primary diamond for Bryan's JV and Varsity softball teams.

In addition, this field is used to host district tournament games for northwest Ohio area teams. These improvements will allow for more opportunities to host future tournaments as well.



Looking for a way to give back to your community and support your charitable interests?

Turn your Required Minimum Distribution (RMD) from your Individual Retirement Account (IRA) into a tax-saving charitable gift through a Qualified Charitable Distribution (QCD). In 2015, the IRA QCD became a permanent part of the internal revenue code. People 70 ½ or older are allowed to transfer up to \$100,000 annually (or \$200,000 for a couple) from their IRA accounts directly to a charity, without first having to recognize the distribution as taxable income potentially saving federal, state and local income taxes.

The Foundation can help you support your charitable interests by offering several fund options: a community fund, designated fund, scholarship fund or a field-of-interest fund. The law prohibits QCD's to a donor advised fund.
