Planting Trees




With a new fiscal year under way, the Bryan Area Foundation has set its sights on a new set of goals, projects, and plans for positively impacting Williams County. A special committee of

Bryan Area Foundation members led by incoming Chair Steve Hess and President Amy Miller prepared for this new year by evaluating the results of the 2020-2023 Strategic Plan. The group determined what had worked well, what had not, and what the focus of the Foundation should be for the next 24 months. The exercise proved fruitful, and in June 2024, the Bryan Area Foundation Trustees adopted a new strategic plan to guide fiscal years 2025 and 2026.

The first focus? *Growing endowed assets.* Increasing endowment fund dollars directly impacts financial giving for generations to come. For this reason, two initiatives in fiscal year 2025 will focus on endowment growth.

First, Bryan Area Foundation Trustees have allocated \$50,000 for matching 25% of all gifts made to new or existing community funds from September 15, 2024, to June 30, 2025 (or until matching funds are exhausted.) Details of the match can be found in the handout enclosed. A successful matching campaign will increase our endowed community fund assets by \$200,000 this fiscal year!



Second, Bryan Area Foundation will be hosting a "Festival of Trees" in our office and around Bryan's historic square this holiday season. The event will include a Christmas tree decorating contest for downtown merchants, a progressive holiday party, the sale of commemorative Bryan ornaments, and a silent auction of Bryan Area Foundation "fund-themed" Christmas trees in our building. The



Festival of Trees will not only be a fundraiser for increasing endowment, but a fun and engaging way for all community members to celebrate the Christmas season. 

In Memory of James "Jim" R. Bard January 14, 1937 - July 21, 2024

We are saddened by the passing of long-time Bryan Area Foundation member, Jim Bard. Along with having served as Co-Chair of the family-owned Bard Manufacturing Company in Bryan, Ohio, Jim prioritized community service in Williams County and beyond. Joining the Foundation in 1991, Jim served on the Development, Scholarship, and Nominating Committees before becoming a member of the Board of Trustees. From 2006-2008, he served as the Foundation Chair, and during this time established the James and Joan Bard Donor Advised Fund. In 2009 he and his brother Richard received the Howard C. and Mary Allene Hawk Good Citizen Award, and both started the Richard and James Bard Technical Scholarship Fund to assist students attending a community, technical, or trade school pursuing a career in HVAC, engineering, or manufacturing.



Jim continued giving back to his hometown by constructing the Bard Centennial Fountain on the historic Williams County Courthouse Square. He wanted to ensure that our town, known as the "Fountain City", had a fountain to commemorate it. And even though we will greatly miss him and his constant support, the legacy he leaves behind will enrich the quality of life in our area now and for generations to come.

To honor Jim and his love for Bryan, a contribution can be made to the Bryan Area Foundation's Community Impact Project Fund, which helps existing building development, promotes the establishment of new businesses, and aids projects that enhance the community experience for residents and visitors.

The Golden Bear Sports Network (GBSN) was awarded a \$2,313 grant from the Bryan Area Foundation (BAF). The

monies will be used to purchase a Starlink satellite internet service ensuring reliable connectivity for livestreaming of Bryan High School sports and arts events. This will enhance broadcast quality, improve the viewer experience, and provide better learning opportunities for student broadcasters. It will also allow viewers living out of town or unable to attend, to watch online. The grant will cover the first year of service, and future sponsorships on the network will pay for subsequent years.

Sandy Cay, Inc., received a \$10,000 grant from the Bryan Area Foundation to assist in renovating their north campus. The monies will help them purchase and install window replacements, new vinvl plank flooring in half the building. and two new doors in the back part of the educational center. The funds will enable the nonprofit to continue to improve programs for students ages 3-22 on the autism spectrum.

The monies will help survivors of crime in Williams County participate in a therapeutic horseback riding/healing curriculum. This therapy program will benefit seven survivors with eight weeks of riding services.

A \$10,000 grant was awarded to the Williams County Family YMCA enabling them to purchase the necessary equipment for community members to maintain their cardiac health. This resource, formerly at Parkview Bryan Hospital, will now be available at the Williams County Family YMCA 24 hours a day. The monies will help acquire a NuStep Cross Trainer, two LifeFitness UBE Armcranks, and a commercial-grade blood pressure kiosk.

Robert F. Flightner Memorial Law Enforcement Scholarship

Congratulations to City of Bryan Police Department Patrolman Justin Coffman and Patrolman John Rathke

on receiving the Robert F. Flightner Memorial Law Enforcement Scholarship. This annual scholarship is for the training and education of law enforcement officers in Williams County. Patrolman Coffman, who just finished his first year of teaching at the police academy at Northwest State Community College, is looking to add to his credentials by completing a course in the use of impact weapons. The \$750 scholarship will help him take the class and use his new knowledge to broaden his instruction abilities at the police academy and provide in-service training at the City of Bryan Police Department. Patrolman Rathke, an assigned narcotics investigator with the Multi-Area Narcotics Task Force (MAN Unit), will use the \$1,500 scholarship to attend the Ohio Peace Officers Training Academy. When done with the two-week course, he plans to use this new information to instruct academy cadets and new law enforcement officers enabling them to be even more successful in their role, and in turn, make their community safer.

A full-time working mom and spouse, she will use the \$6,500 to pay for her classes. Ben is currently the Bryan City School District Director of Vocal Music and will use the \$6,500 to help him earn his Doctor of Musical Arts from Boston University. After graduation, he intends to continue teaching, researching, publishing, and contributing to the arts in Bryan, Ohio, while implementing "best practices for choral music education in rural communities."

The third quarter 2024 PIP meeting was held on Monday, July 29, at the First Presbyterian Church, Bryan. PIP currently has 97 members. Three worthy organizations were nominated:



Open Hands Caring Hearts:

Nominated and presented by new member Cheryl

Sanders, Open Hands Caring Hearts, is a faith-based organization in the New Life Worship Center that collects food, clothing, and paper and hygiene products for residents in need in Northwest Ohio. In 2023, they served 6,262 families representing 15,130 family members with 21% being children and 29% senior citizens. The PIP grant will help the all-volunteer program continue to provide to those in need, as they firmly believe, no one should go without food.

Flair on the Square:

This juried art fair and sale, along with its music, food, and fun, was nominated and presented by Kathy Smith and will be held next year on Saturday, July 26, 2025. The free annual event around Bryan's historic downtown square started in 2022 and is coordinated by an all-volunteer committee. A PIP grant would enable the group to purchase tents and tables for the future.

Edon Friends of the Library:

The last candidate, nominated and presented by Jo Ann Luce, was for the Williams County Public Library, Edon Branch. They would like to purchase a digital sign system to better inform the community of the free events, classes, and activities they offer, especially to those who don't have internet access. A PIP grant would help them raise some of the funds for this \$38,000 project.





Overview

Donations of \$50 or more* to a new or existing named Bryan Area Foundation community fund will be matched by 25% between September 19, 2024, and June 30, 2025 (or until the \$50,000 allocated by the Bryan Area Foundation Trustees has been depleted.) **Donors may also make up to a 3-year pledge to a new or existing community fund utilizing the 25% match.***The maximum gift size to be matched is \$80,000.

Donor Benefits

- The 25% community fund matching campaign is an opportunity for those interested in establishing their own named community fund to do so with as little as \$4,000 in total contributions versus the required \$5,000 minimum.
- The 3-year pledge option allows donors to receive a 25% match for up to 3 years.
- The 25% community fund match is available for donations of \$50 up to \$80,000 in total. (\$20,000 is the maximum match available per donor/household.)
- Donation/payment options include cash, check, ACH payments, gifts of stock, and credit card.
- Contributions to the Bryan Area Foundation are tax deductible up to the maximum allowed by law.

3 Year Pledge Example

Donor X wishes to establish a new named community fund with \$10,000 in principal and wishes to use the 3-year pledge option. In this scenario, Donor X will make a \$2,000 donation in FY25 and will pledge 3 additional \$2,000 annual contributions. The Bryan Area Foundation will match \$2,000 (\$500 each gift) total, making the fund \$10,000 in principal in year four. (The fund's value will likely be greater than \$10,000 at the end of this period because the donations will be invested as they are received.)
